#### Old Business: Approval of February 2020 Meeting Minutes

### **New Business:** Sponsorship Update

Vendor/Sponsorship Coordinator Dickerson provided update on sponsorships. Currently, the total sponsorship is \$29,000. Due to cancellation of Annual Conference, sponsors have the option to request a full refund, or allow FASFAA to keep a portion or all of sponsorship. Per Bookkeeper Francis, credit card refunds should already be processed. Memberclicks shows refund but the funds have not been taken out of the bank account.



Partner Advisory meeting was on Tuesday, 4/14/2020. There was discussion about a Partner Sponsor booklet in a flipbook format. Also, an emergency reference page on the FASFAA website.

#### **New Business:** Webinars and Conference

Successful session on how to spend CARES act funding had over 531 registrants, with 308 non-members and 223 members.

Vice President of Training Bailey and Conference Chair Manselle discussed the tentative webinar series including topics: Mental health (Membership Chair Evans has secured speaker), Components and Building Blocks of Leadership, Financial Literacy Partner Session, and Tax Returns. Tax returns session needs presenter in Region V Representative Gross's absence. President Barkowitz will reach out to Robert Weinerman who presented for SASFAA on Taxes.

Dave Barknicki has agreed to still be part of the virtual conference. NASFAA Annual Conference is cancelled. There was discussion regarding NASFAA certifications being done virtually. There were concerns about the length of the session and charges. Treasurer Conrad will contact Dana Kelly NASFAA to ask about alternatives for training session.

FASFAA Business Meeting will be during the week of 5/25/2020 – 5/29/2020. Awards ceremony will be scheduled after.

The board went into Executive Session for discussion of awards.

#### **New Business: Board Updates**

Site Selection/Event Coordinator Daniels stated that the contract for Transition meeting is not signed yet. Research will begin for the Clock Hour workshop that is in October. He will reach out to Vocational -Technical / Clock Hour Chair Wright and copy President Barkowitz.

President-Elect & Nominations Chair Lovett reminded that FASFAA elections in 2 weeks.

Secretary Cun stated that March and April minutes will be reviewed for approval on the next call. Next board call will be in May in lieu of conference board meeting.
