Description for Fiscal Concerns Committee

The Fiscal Concerns Committee shall advise the Executive Board of Directors on all financial matters. The Fiscal Concerns Committee is chaired by the Immediate Past President and should meet at the time of, or prior to, the Transition Meeting of the Executive Board to prepare a tentative budget to present to the Executive Board at their first meeting of the fiscal year. The newly elected officers of the Association will operate on a tentative budget until the Executive Board approves the budget. The Fiscal Concerns Committee shall schedule an annual audit of the financial records of the corporation as outlined in the audit procedures. The Fiscal Concerns Committee Chair shall provide an investment report to the Executive Board of Directors at each Executive Board Meeting. Ex-officio members of this committee will be President, President-Elect, Treasurer, Treasurer-Elect, and Vendor Sponsor chair. Additional members should be selected at the discretion of the Chair.

Audit

Each year the FASFAA books will be audited in a manner determined by the President and approved by the Executive Board. The audit may be performed by an audit firm, FASFAA members so appointed, or by other individuals outside of FASFAA. It is recommended that an external audit be conducted every five years, not to exceed seven years. The Fiscal Concerns Committee is responsible for scheduling the audit

1. Among other items, the audit will look for documentation for each check written, will review documentation and reconciliation for the income received, make certain all checks and cash were deposited and not used to pay expenses, check to see if the number of members is reconciled with the membership revenue, will count the advertisements in the newsletter to determine if the newsletter sponsor revenue is accurate, and will review all corporate minutes



for the fiscal year. The auditor(s) may also review budget performances and check to determine if activity was in compliance with financial policies.

- 2. The auditor(s) may request a final year-end budget performance with completed activity before closing the audit.
- 3. An audit report will be reviewed with the Treasurer, distributed to the Executive Board and held for a legal record.
- 4. FASFAA may pay a fee for the audit as approved by the Executive Board.

Motion: Treasurer Conrad made a motion to approve proposal on behalf of the fiscal committee.

Discussion ensued Motion carried.

Old Business: Strategic Planning Update

President Barkowitz stated no update. After July 1, will reconvene the past presidents' council.

New Business: FASFAA Business Meeting Planning

President Barkowitz will have slides for business meeting. The session is 1 hour. Suggestion on the floor to do run-through before the meeting. Recess at the end of business meeting and continue meeting at awards ceremony to announce election results and to destroy ballots. Discussion on incentives to get members to register and attend business meeting.

New Business: FASFAA Transition Meeting Planning / End of Year Board Reports

Transition meeting scheduled for June 19 - June 21. Conducted as a virtual transition meeting with old and new positions. Suggestion for 2-1.5 hour meetings. President Barkowitz will make final decision the end of the month and will confer with President-Elect Lovett. End of Year Board Reports due to Secretary Cun by June 10, 2020.

New Business: Proposal for Anthony Jack speech / presentation

\$14,222.94 in currently in CGS Sch Fund to be used. President Barkowitz proposed purchasing up to 200 books: The Privileged Poor by author Anthony Jack. Anthony Jack has agreed to do the virtual speech at no cost but asked to purchase the book. Proposal would be that registrants will receive a book mailed to them after the session. They have to pay for 20-21 membership in order to register. Approximate cost: \$25 per book = \$5000

Motion: Conference Chair Manselle made a motion to sponsor the purchase of up to 200 books for registrants for the virtual Anthony Jack speech / presentation.
